About the law:

If you post or send offensive or inappropriate content to the ENYAN web platform, engage in any disruptive behaviour on the ENYAN web platform, and Artswork/ENYAN considers such behaviour to be serious and/or repeated, Artswork/ENYAN may use whatever information that is available to it about you to stop any further such infringements. General:

Privacy Policy:

This will include records of pages accessed and files downloaded. This information will remain confidential.

On-line purchases:
